A YEAR OF GROWTH AND CHALLENGES CEO SHARES ANNUAL MEETING REMARKS

G ood evening and welcome to Peru High School for your Miami-Cass REMC 84th annual meeting. I'm glad to see so many familiar faces. I would also like to give a special welcome to those attending for the first time. Participation at this meeting is extremely important as this is your co-op and what we do at the co-op is for you. This is a personal way to share information and show our gratitude to all of you.

With no contested elections this year, your board of directors will remain the same. Directors who will be up for election in 2024 are Don Willson, Jim Savage and Scott Marschand. If anyone is interested in running for the board, information will be available in April. Watch for it in your Indiana Connection magazine. Your current directors do an amazing job dealing with this very complex industry and keeping your best interests in mind.

Miami-Cass REMC had a strong year of growth this past year. We had a total of 40 new installs, which was up by 10 from June 2021 to June 2022. That may not sound like a lot, but from 2008 until now we averaged 20-30 new installs. Some years we had negative growth.

The greatest increase we have seen has been in our load. Last August, a company called Digital Egg came on our lines. Digital Egg is a bitcoin mining operation that added eight megawatts of new, constant load. To put that in perspective, the average home uses 1,300 kilowatts. It would take roughly 6,800 homes to use that amount of power. That is 650 more services than we serve now. The company is set under an economic development rate for the next two years. ii-Cass R

Other big projects that we've accomplished included upgrading 4,500 meters and moving the broadband billing into our NISC system. The upgrading of meters and getting fiber to our substations will allow us to implement an outage surveillance system. This system will check every meter every 15 seconds to see if there is electricity serving that meter. It will report back to the system, alerting us of an outage. This will help with outage response times.

Our broadband company, Broadway Broadband, has been unbelievably busy. We currently have 500 miles of line in the air and are serving approximately 1,500 customers. Our Miami-Cass ring connecting all of our substations is 90% complete.

We are also building two other separate rings in Cass and Carroll counties. The Cass ring should be done this fall and we have two years to complete the Carroll ring. With these three projects, plus the grants we received from RDOF, Next Level, Redi Grant and Indiana Connect, we are obligated to build 1,600 miles of fiber and passing close to 15,000

homes in five different counties. After some trial and error and some unforeseen issues, we are finally hitting our stride. With the amount of potential new subscribers, we will be adding customers for many years to come.

With the current situation in our federal government and coming out of COVID-19, there have been many constraints on all electric companies. The cost of materials and equipment used to keep the co-op going has, in some cases, doubled in price.

The lead times for some materials are also dangerously long. We are not in a industry where we can choose not to perform maintenance. Our actions are, in some cases, a matter of life or death.

For instance, on 90 degree Fahrenheit days, the transformers running your homes have increased potential of being overtaxed and failing. Some lead times for transformers are out nine months to a year. We don't have the luxury to stock the amount we would need to sustain multiple failures.

Currently, if we ordered a new digger or bucket truck it would take over two years to get it. The used market is very sparse and the prices are much higher than two years ago.

The pressure on natural gas and coal plant closures has pushed the market prices for energy and capacity up considerably. The prices are on a roller coaster, it seems. This past Dec. 24, the grid we are on became critical, and we were close to implementing rolling blackouts. I'm not telling you this to scare you, but to let you know the infrastructure that feeds us is under constraint like never before. These issues, of course, trickle down and affect us. This brings us to a time where we have initiated a new rate and cost-ofservice study. This study should be done by early fall and we will look at the results and make a decision on which direction to go. I'm confident it will initiate a rate and service increase. The last time we changed rates was in 2014. We don't go lightly into this process and will find changes with the least amount of impact on all of you, our members.

On behalf of the 23 Miami-Cass REMC employees and 18 Broadway Broadband employees, I thank you for giving us your time this evening. Never hesitate to reach out to us if you have questions. I hope you enjoyed it and we will see you next year.

Thank you as well to our fellow area electric cooperative employees who helped judge the projects at both fairs.










