decision. After much discussion, it was decided to make our annual meeting a virtual meeting on Sept. 15. The decision was made with the safety of our members and our employees in mind.

At many of our meetings for the last 81 years, we have had more than 500 members in attendance, usually in a confined space such as a tent or auditorium. With social distancing in place, along with the amount of people allowed in one space, we did not believe we could find a suitable venue for the meeting.

If I would have thrown out the words "virtual meeting" a year ago, some of you would have wondered, "What on Earth is a virtual meeting?" However, today I am sure most of us see or hear the term several times a day on the TV, on the radio and on social media.

The plans for our virtual meeting will be as follows: first, look for an insert in your bill, an email, or a postcard. This will direct you to an issue of our Indiana Connection magazine that you receive every month.

In that issue, we will add several new pages which will include last

WATER RECREATION safety

POOLS AND LAKES

SAFETY - OH MY!

POOL SAFETY:

- Use battery-operated appliances or waterproof covers for electrical appliances so you can avoid the risk of electrical shock.
- If someone in the pool feels electricity, don't dive in. Use a non-metal shepherd's hook to pull him/her out of the water.

RIVER/LAKE SAFETY:


- Avoid swimming or getting in the water near boats plugged into shore power or docks with electrical services.
- Fishing on a dock or boat? Keep a distance of at least 10 feet between your pole or boat and nearby power lines.
- If someone in the water is shocked, turn off the power source and use an insulated device to attempt to remove him/her from the water.

Staying safe while near the water is simple but these tips can be easily forgotten. So, create a checklist for your family and friends to review before jumping in the deep end.

What is energy efficiency?

It has been some time since my last article concerning energy efficiency and your home. I plan to write these more often to help you save energy and money.

A question that is posed to me on a regular basis is "What is energy efficiency and what is energy conservation?" My definition is energy efficiency is using less electricity but not giving up any comfort. Energy conservation is saving electricity by giving up some of the luxuries of life.

As an energy advisor, I concentrate on helping our customers implement energy efficiency measures without sacrificing their way of living. Here are some of the

easy ways you can save energy without spending lots of money:

- The easiest change you can implement to lower your bill is to install LED lights. These lights use a fraction of electricity compared to incandescent bulbs while giving you all the options you may require, such as dimming. The life of LED lights is also much longer than the old bulbs. I also recommend purchasing lights with the ENERGY STAR® logo, as they seem to have a longer life.
- Another simple way to save money and energy is to change the temperature on the thermostat when not at home. In the summer, raising the temperature by three degrees

can save you on the amount of electricity you use.

- Ceiling fans are a great way to stay cool during the summer. However, you should turn them off when not in the room to save on your electric bill.

These few tips can help lower the amount of electricity used this summer. Keep in mind, however, the largest use of energy in a home is for heating and cooling.

Utility poles ARE NOT SIGN POSTS.

If you are having a sale or have something else to post, please do not post it on utility poles.

Staples, nails and tacks used to hang signs — as well as the signs themselves — pose dangers to electric lineworkers who might have to climb that pole when either restoring power following a storm or performing routine maintenance. It may seem innocent, but a small nail partially driven into a pole can have deadly results around high-voltage electricity.

Utility poles sure look attractive for folks wanting to easily hang roadside signs. But a lineworker's job is dangerous enough. Linemen work high overhead with live power lines in all kinds of weather to keep our lights on and our homes cool or warm. Don't add to that danger.
